**Zero Tolerance Agreement**

*This agreement MUST be signed and returned with registration.*

WHEREAS:

- A. International Indoor Gardening Expo Ltd. (hereinafter referred to as the Promoter) is responsible for putting on the Indoor Gardening Expo (hereinafter referred to as the Expo) at the Palais des congrès de Montreal (hereinafter referred to as the Premises) on June 5<sup>th</sup> and 6<sup>th</sup>, 2010.
- B. The purpose of the Expo is to encourage and promote indoor gardening, for the benefit of the home and/or hobbyist gardener.
- C. The Expo is a family event, and will be attended by patrons of all ages.
- D. The Expo is not a venue to advertise, sell, promote, or in any way condone any illegal activities or products.
- E. \_\_\_\_\_ (NAME OF COMPANY OR INDIVIDUAL, hereinafter referred to as the Exhibitor) has rented space at the Expo, from the Promoter.

WHEREFORE IT IS AGREED AND UNDERSTOOD AS FOLLOWS:

- 1. The Exhibitor, his agents, servants or employees, shall not cause to be displayed, advertised, or promoted, directly or indirectly, or by innuendo, any product, service, equipment or activity, or anything whatsoever, which contravenes the laws of Quebec or Canada.
- 2. The condition as set out in Clause #1 above will be strictly enforced, and there will be no exceptions or allowances whatsoever.
- 3. The Promoter, his legal counsel or his authorized representative, shall have at their sole discretion the right to make the determination as to what activity contravenes Clause #1 above, and there is no right appeal from the Promoter's determination once made.
- 4. In the event the Promoter makes a determination that there has been a contravention of Clause #1 above, the Offending Exhibitor shall forthwith, upon notice of the contravention from the Promoter, either verbally or in writing, cause his exhibit to be dismantled and taken down, and the Exhibitor, his agents, servants and employees shall immediately leave the Premises.
- 5. In the event the Exhibitor contravenes Clause #1 above, and is notified of the contravention by the Promoter, then the Exhibitor shall forfeit any deposit, rental payment, or any monies whatsoever paid or payable to the Promoter for the Exhibitor's space at the Expo.
- 6. In the event the Exhibitor is notified by the Promoter of a contravention of Clause #1 above, and the Exhibitor refuses or does not act immediately to dismantle his stall or vacate the rental space, the Promoter shall be entitled to take whatever steps it feels necessary to close down, and dismantle the Exhibitor's rental space, and the Exhibitor shall be solely responsible for any and all costs or expenses incurred by the Promoter in doing so.
- 7. The Exhibitor shall indemnify and save harmless the Promoter for any and all expenses, costs, damages, legal expenses, or any like expenses whatsoever, incurred by the Promoter for the Exhibitor's contravention of Clause #1 above.
